Restarting the Economic Engine: Addressing the Challenges of Disaster Recovery in Coastal Communities

The UN's International Strategy for Risk Reduction Global Assessment Report (2009) estimates that over the past three decades (1975-2008), more than 2.2 million people globally have lost their lives in natural hazard-induced disasters (excluding epidemics), with associated economic losses amounting to USD 1,527.6 billion (ISDR/Global Assessment Report, 2009). These types of events undermine public health, livelihoods and economies and the number of disasters linked to natural hazards continues to rise, exacting a significant toll on coastal communities. Observations made after the 2004 Indian Ocean Tsunami show how neighboring coasts were differentially affected, depending in part on the presence or absence of well-preserved coral reefs, mangroves, and coastal vegetation. It is abundantly clear that healthy coastal ecosystems are part of the foundation of sustainable and productive coastal communities. In many US jurisdictions, coral reefs are the pillars of coastal ecosystems and provide valuable services to coastal communities including food security, income, recreation, tourism and protection from hazards. As such, preserving these and, more importantly, protecting and restoring these services quickly after disruptive events is critically important to ensuring long-term social and economic recovery. Yet recent events have highlighted several challenges coastal communities face in supporting the restoration of ecosystem services and long-term recovery of natural resources in general and coral reefs in particular. The purpose of this roundtable discussion is to facilitate dialog regarding the challenges coastal communities face in managing natural resources prior to and after disaster events and begin to explore alternatives that may begin to address them.
